



City of Tampa Council Redistricting


- City of Tampa's Governing Structure
 - Strong Mayor and City Council system
 - 7 council members
 - Districts 1, 2, 3 are at-large
 - Districts 4, 5, 6, and 7 are single-member districts





Why Redistrict?


- Required by Laws of Florida, Ch 86-404
- Required by City of Tampa Charter
- Required every 4 years
- Next election March 7, 2023





Legal Requirements

- Planning Commission "recommends and approves" a redistricting plan
- Supervisor of Elections proclaims new Single-Member Districts






Legal Requirements (Cont.)

- TPC to hold two public hearings
- Observe precinct boundaries
- Compact and Contiguous Districts
- Single-member districts containing population as nearly as equal as possible



The Three "C"s


- 1.Complete Precincts
- 2.Compact Districts
- 3. Contiguous Districts





Other Considerations

- No redistricting out of office
- Conservative approach
- Minimize negative impacts





"Equal Population"

- The standard is total population,
 - Not voting age population or population by race
 - Census 2020 block-level Total Population

 The "range as a percentage of the mean population" ("range") is the key measure used to assess population equality

Alternatives – Moving Precincts

- Need to reduce Range to less than 5%
 - Moving precincts from a highly populated District to a lower populated District
- Finite number of moves
 - Legal and physical limitations
 - We are proposing four (4) alternatives



No Retrogression

- In all proposed alternatives, Black voters in Council District 5 are at least 50%
- In all proposed alternatives, Hispanic voters in Council District 6 are least 24%






Alternative 1 Closeup





Alternative 1 Map












Alternative 3 Closeup Map





Key Dates

- Currently Gathering Public Input
 - Meetings with Councilmember's
 - Hosting several public meetings (at least one in each council district)
- By June 10, 2022, Planning Commission must hold two (2) public hearings and approve one alternative
 - After approval by Planning Commission, staff will send the proclamation to the Supervisor of Elections
- Before November 1, 2022, the Planning Commission staff will present approved districts to Tampa's City Council as an information item



How to get involved?

- Attend meetings and spreading the word
- Tell us your most preferred alternative
 - Via paper or email
- Send comments to staff
- Speak during Planning Commission public hearings



Conclusions

- Redistricting
 - The Planning Commission recommends and approves redistricting plan for Tampa
 - Staff is hosting several public meetings
 - Planning Commission holds two public hearings
 - Must approve one alternative by June 10, 2022
 - No retrogression in proposed alternatives
 - Next citywide elections on March 7, 2023
