HILLSBOROUGH TRANSPORTATION PLANNING ORGANIZATION POLICY COMMITTEE MEETING, APRIL 13, 2022 DRAFT MINUTES

I. CALL TO ORDER, PLEDGE OF ALLEGIANCE (Timestamp 0:07:16)

Chair Kemp, called the meeting to order at 8:35 AM and led the pledge of allegiance. The regular monthly meeting was held in-person and virtual via WebEx.

II. ROLL CALL OF COMMITTEE MEMBERS & WELCOME TO OTHER TPO BOARD MEMBERS (Gail Reese, TPO Staff)

The following members were present in person: Commissioner Pat Kemp, Councilman Guido Maniscalco, Commissioner Harry Cohen, Commissioner Kimberly Overman, Charles Klug

The following members were present virtually: Commissioner Mariella Smith

The following members were Excused/Absent: Bob Frey

Welcome to other TPO Board Members present: Councilman Joseph Citro, Planning Commissioner Cody Powell

A quorum was met in person.

A. Vote of Consent for Remote Member Participation

Commissioner Cohen made a motion to approve participation by remote members of the committee; seconded by Councilman Maniscaldo. Voice vote; motion passes unanimously.

III. APPROVAL OF MINUTES (Timestamp 0:08:48) – March 9, 2022

Chair Kemp sought a motion to approve the meeting minutes from February 9, 2022. Councilman Maniscalco so moved, seconded by Commissioner Cohen. Voice vote; motion passes unanimously.

- **IV. PUBLIC COMMENT** (*Timestamp 0:09:11*) 3 minutes per speaker to a maximum of 30 minutes.
 - Rick Fernandez From Tampa Heights. Spoke about the UPWP item on the agenda today. Noted that the CAC had a presentation of it at their April meeting. Noted the TPO Recommended Project List in the slide presentation., Other Projects Contingent on Funding. Bullet Point number 2 is the I-275 Conversion Study Phase 1, otherwise known as Boulevard Tampa. The CAC recommended a Boulevard Tampa study in 2019 and the TPO Board approved the study at that time. Understands it hasn't moved. Is giving the Policy Committee a "heads up" about the slide and information on it. There is an estimated cost of \$580,000 and four bullet points on the slide and no cost associated with any bullet point. Is requesting that this feasibility study for Phase 1 be reasonably priced out.

- V. Roundtable with Agencies on Transportation Improvement Program (TIP) Funding Requests (Johnny Wong, TPO Staff) (Timestamp 0:12:27; NOTE: there is a gap in the recording at the beginning of this item)
 - **A.** Representatives from the City of Plant City, Hillsborough County, the City of Temple Terrace, and TBARTA. Dr. Wong reviewed the timeline of the TIP for May and June. Will finalize a draft for review and complete an equity analysis. Hillsborough County project letter and handout are included at the end of the minutes.

Discussion:

Analysis of any of the projects that would be eligible for the investment infrastructure bill dollars was requested for the May meeting along with a financial analysis of what would be required on a local level and the overall financial commitment. It was noted that it was good to see the Upper Tampa Bay Trail after being dormant for a decade.

VI. ACTIONS ITEMS (*Timestamp 0:32:28*)

- A. TPO Apportionment Plan Draft for Circulation (Elizabeth Watkins, TPO Staff)
 - Review of possible voting scenarios Elected officials, Appointed Agency Officials, Agency Staff; Elected Officials; Elected Officials from Jurisdiction Governments.
 - Preference was shown for option two which includes elected officials Sunshine Statute, looked at the other MPOs (14 of 17 other MPOs have over 90% representation of elected representation; Hillsborough County has 63%), looked at population changes
 - Went over proposed votes and representation two main changes: technical advisors would not be voting members, adding additional 2 representatives from Hillsborough County to reflect census information.

Discussion:

It was brought up that it could be challenging to serve both the BOCC and the agency that an elected official represents. It would require all the Commissioners to be on the TPO Board. There is concern that the technical agencies that are advisors will not show up. It was noted that the City of Tampa makes up a good portion of the county and that should be reflected in the voting representation. Agencies could have different perspectives than the agencies being represented by elected officials. It was noted that the MPOs were originally founded to have local community voices about federal funds and matching funds being spent; not that every stakeholder has a voice about the expenditures of the MPO. It makes sense to have the agencies have a technical advisory role versus a voting role much like the FDOT. Elected officials are responsible for those types of decisions based on the citizens and not special interests. It was asked how many of the Planning Commissions in the state have TPO and MPOs. There are regional planning councils around the state. It was noted that the current structure of the board gives a lot of different voices. The reapportion plan would give the voice to the politicians and not the people. The Planning Commission would no longer have a seat at the table and could diminish their voice. With the

county having seven votes, the cities would also be diminished in their voice. It would be good to consider a different breakdown. The MPO Act includes major modes of transportation including seaports and airports. It is not developers; the statute says major modes of transportation. Having agencies have a voice is good because it's about transportation but also intermodal matters. Everyone must understand the issues affecting each piece of the transportation system that could have an impact on the community. Important improvements have been made and more important decisions are going to be made; having a well-rounded representation is necessary to make those decisions. It was noted that the elected officials have to face the community for their decisions that other members do not. A point was made that the elected officials do not vote as a block and that BOCC members represent the cities within Hillsborough County. It was brought up that the TPO Board should be brought back to what it was originally intended to be with the technical advice from the agencies.

Recommended Action: Approve the draft Apportionment Plan for circulation to the TPO's advisory committees and board.

Commissioner Overman moved to approve the draft Apportionment Plan for circulation to the TPO's advisory committees and board, seconded by Commissioner Smith.

Discussion:

It was noted that adding the entire BOCC adds representation for the three cities in the county. It was brought up that the cities should have additional representation as well. Major highways come together in the City of Tampa. The Florida Statute is proportional representation.

Commissioner Kemp called for a roll call vote; the motion passes 5-1.

- **B.** Letter requested by Policy Committee regarding I-75 PD&E Studies (Beth Alden, TPO Director) (Timestamp 1:21:03)
 - A copy of the letter is included in the TPO Policy April Agenda Packet.

Discussion:

It was noted that the letter does not reflect that the managed lanes do not state that tolls are opposed. Commissioner Overman would prefer that the TPO has to approve the lane management strategy moving forward. It was noted that there are a variety of terms that mean tolls by FDOT. It needs to be very clear that, as approved at the March meeting, tolls would be prohibited unless approved by the TPO. Suggested language change to the letter.

Commissioner Overman moved to send the letter to the main board with the amended language/revision; seconded by Councilman Maniscalco and Commissioner Smith. Roll call vote, motion passes 6 – 0.





Smart Cities Mobility Plan Update

Summary

The Smart Cities Mobility Plan represents an evolution of the 2013 Intelligent Transportation Systems Plan Update. The plan will include several new features to meet the needs of planners and traffic operations teams across Hillsborough County. Chief among these new features is a prioritization matrix, which may resolve a gap in the Transportation Improvement Program (TIP) ranking methodology. The new prioritization matrix allows non-traditional Smart Cities projects to be ranked and compared both against one another and against traditional project types.

Staff will provide a summary of the Smart Cities Mobility Plan's findings, its recommendations, and will demonstrate how the prioritization matrix is being used to rank projects in the TIP priority list.

Summary

Engaging the public is critical to the TPO's success. Working with the community ensures TPO plans and products better reflect the public's values and preferences. The Public Participation Plan (PPP) helps balance the professional and technical expertise brought to projects with the community's input, and also helps the TPO gain the broad support needed to ensure that transportation plans and programs are implemented.

The PPP describes the TPO's strategies and techniques to inform and engage the public in transportation planning issues, with the purpose of maximizing participation and effectiveness. At least once every two years, the TPO reviews its public participation efforts, using "measures of effectiveness" that fall into the following categories:

- Visibility & Productivity
- Participation Opportunities
- Public Interest & Feedback
- Input Results

The report reviews the TPO's public engagement efforts during 2020 and 2021. Recommendations produced in this review will lead to amendments of the PPP and set the stage for engaging the public in the update of the Transportation Improvement Program (TIP) and 2050 Long Range Transportation Plan (LRTP).

Transportation Improvement Program (TIP) Priorities Update: Preliminary Draft

Summary

Staff has prepared a preliminary draft of the Transportation Improvement Program document for the fiscal year period of 2022/23 – 2026/27. The TIP document includes three important lists:

- Existing priorities funded for construction: these are priorities that are under construction or have funding to begin construction within the next five years. This list also includes partially funded projects, which are listed to show community support, while they await completion.
- 2. Candidates for new funding: these are priorities that need federal and state funding because they have been shown to address urgent transportation needs in the community. This list organizes projects into the appropriate investment program and ranks them in priority order based on the estimated impact they will have on the community's goals.
- 3. All projects to be funded in the next five years: this list is quite large and includes projects programmed by the FDOT based on our previous year's priority list. It also catalogs all projects in our partners' local Capital Improvement Programs, even though the TPO does not control what projects appear in the CIPs.

Staff will present these three preliminary lists so that committee members can become more familiar with the TIP and its elements prior to the June meeting, during which committees will take action.
