I. Call to Order, Pledge of Allegiance (*Timestamp 0:00:20*)

Chair Ross called the meeting to order at 8:30 AM and led the pledge of allegiance. The regular monthly meeting was held in person and virtually via WebEx.

II. Roll Call of Committee Members & Welcome to Other TPO Board Members (Gail Reese, TPO Staff) (*Timestamp 0:00:44*)

The following members were present in person: Mayor Andrew Ross, Councilmember Joseph Citro, Commissioner Gwen Myers, Commissioner Michael Owen, Charles Klug, Commissioner Joshua Wostal

A quorum was met in person.

III. Approval of Minutes (Timestamp 0:01:20) – February 8, 2023

Chair Ross sought a motion to approve the meeting minutes from February 8, 2023. Commissioner Myers so moved, seconded by Commissioner Owen. Voice vote; motion passes unanimously.

V. Action Item (*Timestamp 0:02:02*)

- A. Executive Director Job Description and Recruitment Timeline (Meghan Betourney, TPO Staff)
 - Went over the timeline, recruitment, and interview process.
 - Review of TPO Executive Director job description.
 - Looked at placements for the TPO Executive Director opening for recruitment.

Recommended Action: Make a recommendation to the Board regarding the proposed job description and timeline.

Discussion:

A printed copy of the timeline was requested. It was suggested that the new Executive Director be able to work with Ms. Alden for a longer time than proposed and move the starting date to have that happen. It was requested that the advertisement be placed in the minority newspaper. It is noted that the overall TPO Board will need to decide who will make up the selection committee. Once that is selected, the interview dates will need to be determined right away. It was clarified that the panel will be an odd number. Melissa Zornita has requested to be part of the panel along with Mayor Ross. Commissioner Myers has also requested to be on the panel.

Commissioner Owen moved for approval of the timeline, seconded by Commissioner Wostal. The voice vote passed unanimously.

VI. Status Reports

- A. Gandy Boulevard Bridge PD&E (Craig Fox, FDOT) (Timestamp 0:15:27)
 - Review of the project area, the purpose, and the need for the project.
 - Project is broken into three segments.
 - Important east-west corridor in Pinellas and Hillsborough Counties.
 - Went over typical existing lanes.
 - Reviewed the preferred typical sections for each of the segments.
 - Include elevated and at-grade roadways.
 - Looked at access management, stormwater management, and floodplain compensation.
 - The environmental effects are being looked at in four categories.
 - The proposed plan is consistent with the long-range transportation plans of Forward Pinellas and Hillsborough County.
 - Reviewed the timeline, schedule, costs and funding schedule.

Discussion:

It was noted that the TPO Staff has reviewed this information and does not recommend making any comment at this time. It was brought up that the Gandy Extension has been a great benefit and this project is likely to do the same. There was a question about the old section of the bridge and whether or not it could be used for a bike/pedestrian bridge for a while. This section is going to be taken down to avoid the county having to incur maintenance and demolition expenses at a later time as it degrades further. This happened with the Friendship Trail Bridge. It was noted that the Port of Tampa Bay could use some of the concrete rubble when it comes down.

B. Planning Commission Annual Update and Plan Hillsborough Strategic Plan (Melissa Zornitta, Planning Commission Executive Director) (*Timestamp 0:35:45*)

- The Planning Commission, TPO, and River Board have a joint strategic plan with a five-year horizon.
- Reviewed the seven focus areas and provided highlights.
- This year is the end of the strategic plan and has set a retreat for June to engage for the update.

- **B. FDOT Rail System Plan and MPOAC Freight/Rail Committee Updates** (Elizabeth Watkins and Wade Reynolds, TPO Staff) (*Timestamp 0:43:00*)
 - Went over what the Rail System Plan is and its role in the state.
 - Looked at strategies for passenger and freight.
 - Reviewed funding options available.
 - Went over the needs assessments for passenger and freight.
 - Looked at Freight and Passenger Rail Investments short-term through 2026 and longterm from 2027 – 2042.
 - The next steps the full plan is on the FDOT website.
 - Explained what the MPOAC is provides a local voice to FDOT. Freight and Rail is a subcommittee established in 2013 and expanded in 2021.
 - Freight Priorities Program came in in 2018.
 - o Passenger Rail Priorities Program developed in 2023 in response to new funding sources.
 - Program impacts MPOs can communicate freight priorities and coordinate them.
 - 2023 priorities are being put together now.

Discussion:

It was noted that there is an intention to fill out applications for projects already on the TPOs adopted priority program. It was brought up that for every ~110 rail cars, it takes ~1000 trucks off the road. Moving freight on rail is very important. There is a monopoly with CSX and they can be difficult to deal with, particularly when it comes to passenger rail. Any assistance with grant funding is appreciated. Funding awarded in 2020 still has not been received by Port Tampa Bay. The longer projects are delayed, the more the price will go up. The grade separation on US 41 is going to be very important to keep traffic moving. About 90% of any rail ticket is subsidized by the taxpayer in the United States; it was asked whether that is going to be considered by FDOT when promoting passenger rail. Yes, FDOT is doing a lot of cost analysis. It was noted that the chlorine plant is going out of Rattlesnake Point which will eliminate that freight need. Brightline is terminating in Ybor City and there will not be enough transportation for users to maneuver the city. Utilizing the southbound track would be ideal for commuter rail. A multimodal hub is going to be needed.

VII. OLD & NEW BUSINESS (Timestamp 1:03:02)

 Commissioner Wostal brought up that the presentations for the Policy meeting were not different from the presentations made at the regular meeting. Perhaps it could be considered to combine the meetings unless there is a topic that needs to be brought up separately. Chair Ross noted that this committee exists at the will of the TPO Board. It makes sense for things where a deeper dive needs to be done. It is up to the TPO Board to see the value of the committee. It is up to the committee to decide what types of things they wish to hear about in this committee meeting. Ms. Alden noted that the TPO Board did not want to spend more than two hours at a meeting. The Policy Committee has been utilized to screen less controversial items. This may be a topic that the TPO Board may wish to revisit. Commissioner Owen noted that the redundancy of government resources may be a waste, and the political makeup of the committee and the Board may be different. Perhaps it could be discussed whether or not the Policy Committee could meet at the request of the TPO Board pending specific topics. Commissioner Myers noted that the status reports brought up today was good information but not necessarily policy related. Ms. Alden brought up that having the Policy committee participate in the statewide program of identifying projects is important and that having the information brought before members in a public forum is a policy direction. Do not wish to waste anyone's time. Commissioner Wostal questioned what part of today's meeting is separate from what the Board would be hearing. Chair Ross asked that the committee give him one month to come up with a plan for the Policy Committee based on what other MPO/TPOs do around the state and bring some suggestions to the committee and then make recommendations to the Board.

- Commissioner Owen asked Ms. Zornita about the target objectives for the TPO when it comes to grant funding, priorities, and the correspondence that was submitted. There is a copy of that letter in the TPO Board meeting agenda for today.
- It was announced that Cameron Clark has received a promotion to Division Chief; will continue serving the TPO Board.

HART is seeking funding support from the Hillsborough Transportation Planning Organization (TPO) over the next five years to move forward with its priorities. 

The City of Plant City (City) appreciates the efforts of the TPO and it's partner agencies in advancing several of the City's priority projects. Our understanding of the current status of these projects is summarized below:

- ✓ Alexander Street / James Redman Parkway Intersection Improvements has been funded for Design and Construction *through* FPN 440733, in conjunction with the SR-39 resurfacing project from Alexander Street to Charlie Griffin Road. FDOT will administer the project. Construction is scheduled for completion in late 2023.
- ✓ Alexander Street / Jim Johnson Road Intersection Improvements has been funded for Design through FPN 440736. FDOT will administer the project. Funding for Right of Way (R/W) and Construction is sought for this project.
- ✓ South Park Road and Coronet Road Intersection Improvements has been funded for Design through FPN 440734. FDOT will administer the project. Funding for R/W and Construction is sought for this project.
- ✓ Canal Connector Trail Feasibility Plan has been funded through the TPO's Unified Planning Work Program; the study is essentially complete. Funding for Design and Construction of Phase I is sought.
- ✓ US 92 Widening to four lanes from Maryland Avenue to South County Line Road has completed PD&E through FPN 438998. FDOT will administer the project. Funding for Design is sought for this project.
- ✓ Rice Road Extension 2022 Priority #86 is no longer considered feasible due to large commercial development within the anticipated alignment. This project may be removed from the priority list.

✓ East Sam Allen Road Extension – 2022 Priority #75 is no longer considered feasible due to industrial and residential development within the anticipated alignment. This project may be removed from the priority list.

Per your request, listed below for your consideration are the City's priorities to use during this year's development of the TPO's Transportation Improvement Program (TIP). They are in order of importance [highest first]:

• Canal Connector Trail -Phase I – Snowden Park to Cherry Street Park - New

Costs for Phase I are estimated at \$250,000 and \$1,500,000 for Design and Construction respectively. Design & Construction funds Costs (\$1,750,000) are sought at this time. The 2.25 mile mixed use path will make use of publicly owned road and drainage right of way and no significant acquisitions are anticipated. The path will connect bicyclists and pedestrians of all abilities with local neighborhoods as well and intersect other existing and proposed facilities providing access to mid-town and downtown areas.

• Collins Street Complete Street – Alsobrook Street to Alexander Street – New

The 2013 Collins Street Corridor Study provided a framework to implement a Complete Street renovation of Collins Street from Baker Street south to Alexander Street. Phase I of the project has been designed and is scheduled for completion of construction by December 2025. Design of Phases Ia and II are underway. The remaining section from Alsobrook Street south to Alexander Street is not funded. Design costs (\$1,000,000) for the remaining 1.25 miles are sought at this time. Complete Street improvements will improve accessibility for bicyclists and pedestrians of all abilities, and enhance re-development in the Mid-Town and Downtown areas.

• State Road 39 Complete Street – Alexander Street to Trapnell Road - New

The State Road 39 corridor south of Alexander Street is a growing residential and commercial center. The City requests that FDOT undertake planning and project development necessary to guide pedestrian, bicyclist, and vehicle access throughout the 1.5 mile long zone. Funding for this preliminary effort is estimated at \$500,000.

- Alexander Street/Jim Johnson Road Intersection Improvements. 2022 Priority #41 Previously estimated construction cost of the project was \$2,000,000. FDOT's current Long-Range Estimate of Construction cost is on the order of \$100,000. Additional Construction cost is anticipated for railroad crossing modifications & improvements. R/W requirements & cost estimate is not available. Based on currently available information and adjustment for cost increases, combined R/W and Construction costs are estimated not to exceed \$1,000,000. Improvements to this intersection will aid traffic flow by widening the intersection, providing for dual left turn lanes onto Jim Johnson Road from Alexander Street. This intersection will require widening at the crossing of CSX Railroad.
- South Park Road/Coronet Road Intersection Improvements. 2022 Priority #42 Previously estimated construction cost of the project was \$2,000,000. FDOT's current Long-Range Estimate of Construction cost is on the order of \$200,000. R/W requirements & cost

estimate is not available. Based on currently available information and adjustment for cost increases, combined R/W and Construction costs are estimated not to exceed \$750,000. Improvements to this intersection will aid traffic flow by widening the intersection, allowing for dedicated left turn lanes onto Park Road from Coronet Road and East Alsobrook Street. Other intersection improvements would include a relocated right turn lane onto Coronet Road from Park Road and a relocated right turn lane from East Alsobrook Street onto Park Road.

• US 92 – Widening to four lanes, Maryland Ave. to County Line Road 2022 Priority #62 Previously estimated construction cost of the project was \$3,700,000 and \$42,000,000 for Design and Construction respectively. R/W requirements & cost estimate is not available. Based on currently available information and adjustment for cost increases, Design cost is estimated not to exceed \$4,750,000. R/W and Construction funding will be requested in future years. Improvements include expand to four lanes from Maryland Avenue to South County Line. Significant industrial growth has occurred and is expected to continue in this area. The project would implement a recommended improvement from the Freight Logistics Zone Study, May 2016. In addition, this would reduce truck and passenger traffic on Interstate-4.

A completed TIP Priority Project Application is attached for each of the new priority projects listed above.

For those projects that are eligible for and receive federal and/or state funds that require Local Agency Program (LAP) certification, we request they be sponsored and managed by either Hillsborough County or the Florida Department of Transportation, as appropriate. All of these proposed projects are consistent with the *Imagine 2040: Plant City Comprehensive Plan.*
